

## Singapore Sports Hub #HuatRun Social Media Contest Terms and Conditions

- General: These terms and conditions ("T&Cs") apply to the Singapore Sports Hub #HuatRun Social Media Contest ("Contest") organised and operated by Kallang Alive Sport Management Co Pte. Ltd. ("KASM"). By taking part in the Contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Contest.
- 2. Prohibited Parties: Employees of KASM and employees of KASM's subsidiaries, divisions, affiliates, agents, and partners (collectively, the "Representatives") and their respective immediate family members are not eligible to enter or participate in the Contest. Any other persons or companies professionally connected with the Contest or directly involved in organizing, promoting, operating, or conducting the Contest are not eligible to enter or participate in The Contest. It is the participant's responsibility to ensure that his/her entry and acceptance of the prize does not contravene these T&Cs and/or any local laws or regulations.
- Participation: Participation in the Contest is subject to the applicable rules and regulations of the Contest. In the event of any inconsistency between these T&Cs and the applicable rules and regulations of the Contest, the rules and regulations of the Contest shall prevail. No entry fee or purchase is necessary to enter the Contest.
- KASM's Rights: KASM hereby expressly reserves its rights in its sole and absolute discretion to:
  - (a) exclude any person from participating in the Contest;
  - (b) request a winner to present their NRIC or other proof of identity for verification purposes;
  - (c) void an entry of or disqualify a participant; and
  - (d) draw reserve winners to replace any successful winner(s) who may subsequently be found to be ineligible and disqualified or for such other reason that KASM may determine in its reasonable discretion.
- 5. For the avoidance of doubt, KASM shall be under no obligation to provide reasons or justifications for exercising any of its rights above. KASM hereby expressly reserves its rights to pursue legal action against any individual believed to have undertaken fraudulent activities or other activities harmful to this Contest and/or the entry submission process.
- Cancellation: KASM hereby expressly reserves its rights to cancel and terminate the Contest at its sole and absolute discretion and without notice and further liability to any participant.
- Privacy: The participant hereby acknowledges and agrees that his/her personal data may be collected, used and/or disclosed by KASM for the following purposes:
  - (a) facilitating and administering the Contest;
  - (b) delivery of the prizes (including to contact the participant for the administration of the prizes);
  - (c) for use in publicity and promotional materials (publicity purposes); and
  - (d) sending marketing updates and messages of KASM's events, activities, and promotions by electronic mail.
- In the course of carrying out the purposes, KASM may disclose the participant's personal data to its affiliates, subsidiaries and/or thirdparty service providers.
- KASM shall adhere to the Personal Data Protection Act 2012 in its
  collection, use and/or disclosure of the personal data collected from

- Prizes: All prizes won by successful winners are not transferrable or exchangeable for cash, credit or kind. KASM shall not replace any

- prizes which are lost, stolen or damaged. KASM reserves the right, at any time in its sole and absolute discretion, to substitute, withdraw, add or alter any of the prizes offered without notice to the participants. All prizes are subject to the respective issuers' terms and conditions. KASM shall not be responsible in any way whatsoever for the validity, utility, suitability, usability, or fitness for purpose of the prizes, which shall be the issuer's sole liability. Except to the extent that they may not be excluded by law, no representations, warranties, terms or conditions that are not expressly stated in these terms and conditions apply to this Contest nor in respect of the prizes and all implied warranties are excluded, including but not limited to, the implied warranties of satisfactory quality, merchantability or fitness for a particular purpose of any of the prizes. Prizes must be utilised within the specified validity period and no requests for extensions will be entertained.
- <u>Publicity</u>: KASM reserves the right to publish or display the names, photographs, videos, or any likeness of the participants of the Contest for promotional, marketing, advertising and publicity purposes.
- 12. <u>Disqualification</u>: KASM reserves the right, in its sole and absolute discretion, to disqualify any individual found to be ineligible or tampering with the process or the operation of the Contest or to be acting in violation of any applicable legislation in Singapore.
- 13. <u>Liability</u>: KASM shall not be liable to the participants in any manner whatsoever for any claims, losses, injuries, damages, costs, interests, or expenses in connection with and/or arising out of the Contest, the redemption, use or the terms of use of the prizes. Each participant agrees to waive and release KASM and its Representatives from the aforementioned claims and liabilities. This includes, without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy, to the extent permissible under any applicable written laws.
- 14. <u>Indemnity</u>: To the maximum extent permitted by law, each participant and anyone entitled, authorised or agreed to act on his/her behalf, agrees to indemnify KASM and its Representatives from any losses, damages, costs, expenses, claims or liabilities of any kind arising in connection with their participation in the Contest, to the extent permissible under any applicable laws.
- 15. <u>Modification of Terms</u>: KASM reserves the right to amend or supplement any of these T&Cs including but not limited to the prizes, duration, date of selection of the winners and any other matters in respect of Contest from time to time at its sole and absolute discretion and without notice.
- 16. <u>Decisions</u>: The decision(s) of KASM on all matters relating to the Contest will be at its sole and absolute discretion and will be final and binding on all participants and winners. No enquiries, appeals, verbal or written, shall be entertained. In the event of any inconsistency between these T&Cs and any brochures, advertisements and marketing or promotional materials relating to the Contest, these T&Cs shall prevail.
- 17. <u>Miscellaneous</u>: These T&Cs are governed by the laws of the Republic of Singapore. KASM and each participant and winner hereby agrees to irrevocably and unconditionally submit to the exclusive jurisdiction of the courts of Singapore. A person who is not a party to these T&Cs shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any provision of these T&Cs. To the extent that any provision of these T&Cs is held by a court of competent jurisdiction to be wholly or partly illegal, invalid or unenforceable, the same shall be deemed to be severed from these T&Cs and shall be of no force and effect. The remaining provisions shall remain in full force and effect.
